



PRIVACY DISCLOSURES FOR CALIFORNIA RESIDENTS

These disclosures supplement the Privacy Policy For Affiliates Established in the U.S. (the “**Policy**”) of Luvata Fabrication North America, LLC (“**Luvata**”), which can be found at www.luvata.com (the “**Site**”). They are provided pursuant to the California Consumer Privacy Act, as well as any amendments thereto (the “**CCPA**”) and apply only to residents of California. Luvata may revise these disclosures from time to time by posting the revisions on the Site, with such revisions only taking effect upon their being posted.

Required Disclosures

Categories of Personal Information Collected

Luvata collects the following categories of personal information:

- Identifiers (e.g. name, Internet protocol address, email address, physical address, and phone number);
- Internet and Network Activity Information; and
- Commercial Information.

Categories of Sources of Personal Information Collected

Luvata collects personal information from the following categories of sources:

- Consumers using the Site;
- Third parties using the Site on behalf of consumers; and
- Third parties with whom or which Luvata has a business relationship.

Purposes for Collecting Personal Information

Luvata uses personal information for the following purposes:

- To achieve the purposes for which you, a third party on your behalf or a third party with whom or which Luvata has a business relationship provided personal information (e.g. if you provide personal information to order products or services, Luvata will use such information to respond to fulfill such order);
- To fulfill orders for products or services, or to process returns of products;



- To provide you with support, and to respond to your questions, regarding products and services of Luvata;
- To send e-mail messages, newsletters and other information that Luvata believes to be of interest to you;
- To consider consumers for employment or employ consumers;
- To respond to requests from law enforcement or other governmental authorities;
- To comply with any applicable law or legal obligation;
- To prosecute or defend itself in a legal dispute or proceeding; and
- For any other business purpose not prohibited by applicable law.

Categories of Third Parties with whom Luvata Shares Personal Information

Luvata shares personal information with categories of third parties that enable Luvata to achieve the purposes for which it collects personal information. Luvata does not sell personal information to third parties.

Specific Pieces of Personal Data Collected

Luvata collects the following specific pieces of personal information:

- Names;
- E-mail addresses;
- Physical addresses; and
- Phone numbers.

Summary of Consumers' Rights

Right to Request Information

You have the right to request the following information from Luvata:



- The categories of your personal information collected by Luvata;
- The categories of sources of your personal information collected by Luvata;
- Luvata's business or commercial purposes for collecting or, if applicable, sharing your personal information;
- The categories of third parties with which or whom Luvata shares your personal information;
- The specific pieces of your personal information collected by Luvata; and
- If Luvata disclosed your personal information to a third party for a business purpose, the categories of such personal information, and the categories of third parties to whom or which such personal information are disclosed.

Deletion Rights

You may request that Luvata delete any of your personal information retained by Luvata, except that Luvata need not delete any such personal information as set forth in the CCPA. Without limiting the generality of the preceding sentence, Luvata need not delete any of your personal information necessary to:

- Complete the transaction for which Luvata collected your personal information, fulfill the terms of a written warranty or product recall conducted in accordance with U.S. law, provide a good or service requested by you or reasonably anticipated within the context of Luvata's ongoing business relationship with you, or otherwise perform a contract between Luvata and you;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity, or prosecute those responsible for such activity;
- Debug products to identify and repair errors that impair intended functionality;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with Luvata;
- Comply with a legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided it.



Verifiable Consumer Requests

To exercise your rights under the CCPA, you must submit a verifiable consumer request to Luvata as set forth in the Policy. Only you, or a person registered with the California Secretary of State that you authorize to act on your behalf, may make a verifiable consumer request relating to your personal information.

You may only make a verifiable consumer request pursuant to the CCPA twice within a 12-month period. The verifiable consumer request must:

- Provide sufficient information that enables Luvata to reasonably determine you are the consumer about whom Luvata collected personal information or an authorized representative; and
- Describe your request with sufficient detail that enables Luvata to properly understand, evaluate, and respond to it.

Luvata can only respond to your request if it can verify your identity or authority to make the request and confirm the personal information relates to you. Any personal information provided in a verifiable consumer request will only be used by Luvata to verify the requestor's identity or authority to make the request.

Response

Luvata endeavors to respond to a verifiable consumer request within 45 days of receipt. If Luvata requires more time (up to an additional 45 days), Luvata will inform you of the reason and extension period in writing. Luvata will deliver its written response to your request by mail or electronically, at your option. Any disclosures provided by Luvata will only cover the 12-month period preceding receipt of your request. Luvata will only charge a fee to respond to your request if it is excessive, repetitive, or manifestly unfounded.

No Discrimination

You have the right to be free from unlawful discrimination for exercising your rights under the CCPA.
